

#### **Generic Evidence**

- Chain of custody (bag of cocaine)
- Questions: Have you seen exhibit A, When and where; what did you do
- How do you know it is the same object



## Chain of Custody Continued, generic

- Has it been altered other than the identifying sticker
- Is it in the same or substantially similar condition as when you first saw it
- How did it get to the courtroom today?
